### ADJUSTMENT/ANALYSIS OF 2020 CIVIL UNREST CLAIMS

The 2020 U.S. civil unrest claims provided unprecedented challenges to the insurance industry. Specifically, adjusters had to devise novel methods to develop facts necessary to address hundreds of claims, particularly when the insured was a national chain with locations throughout the country and, in some cases, with many damaged locations also clustered within a particular geographic area. Attorneys were faced with having to rely on case precedents that may have involved similar perils (e.g., "riot," "vandalism," "civil commotion") but that were applied to much more limited geographic scopes and were being applied to claims covering areas across the United States. Consequently, policy language, choice of law, and several other factors have had a bearing on how it would be anticipated that courts would adjudicate a number of coverage issues, particularly the application of deductibles and/or self-insured retentions. Brokers were also faced with managing client expectations as different methodologies were developed to manage and to resolve these claims.

#### TEXAS FREEZE 2021 – THE DEREGULATED ENERGY MARKET AND INSURANCE CLAIMS CHALLENGES
