

WORKSHOP 2 (2 Hour) Business Interruption Implications of Wide Area Damage

On May 27, 2010 Justice Hamblen ruled in favor of Generali against Orient-Express Hotels (OEH) in what has become a landmark ruling in UK Insurance Law. Operating as a luxury hotel in New Orleans, the claim followed the devastating effect of Hurricane Katrina in 2005. The ruling ultimately held that there could be no indemnity under the business interruption policy since the 'but for' test was not satisfied as a result of concurrent independent causes of loss. Since the ruling, countless reams of commentary have been produced regarding this claim and its implications. Given the prevalence of current hurricane and other Wide Area Damage (WAD) losses in the market today, it has never been more relevant.

This session will address what actually happened in the OEH v Generali claim. How was the claim presented and handled and how did Insurers present their arguments? How was Generali's actual forensic accounting expert able to measure the WAD impact to the satisfaction of the court? What relevance does this ruling have in US law? If this case had been run in the US would the ruling have been the same? Does the OEH ruling have implications outside the world of property damage claims? Will the OEH ruling inevitably results in price gouging and windfall profits as highlighted in 'Island Theory'?

WORKSHOP 3 (2 Hours) I Feel the Earth Move Under M

I Feel the Earth Move Under My Feet: Handling Claims Involving Geotechnical Issues and Earth Movement

Commercial claims involving complex geotechnical issues present unique challenges. An insurer faced with this type of loss will need an experienced geotechnical consultant, a structural engineer and counsel to guide them through the investigation as to the cause and scope of loss, as well as coverage issues which arise. Dr. Richard Finno, a professor at Northwestern, will teach us, in some depth, about geotechnical investigations, soil properties, the relationship between construction activities and ground movements, and the tools used to determine soil conditions and the cause of loss. Mark Krueger, a structural engineer, will provide an overview of methods commonly used to evaluate foundations and other structures that are impacted by earth movement issues. Clark Schirle, a commercial first-party attorney, will discuss earth movement coverage issues that arise. All three of them have worked together on these types of losses. Throughout the presentation, they will illustrate these issues by using examples from complex commercial claims they have worked on over the years.

Dr. Ed Coats

Obstetrician & Adventurer

Ed Coats was chosen to join James Cracknell and Ben Fogle on their race to the South Pole, the first attempt of its kind since Captain Scott was beaten by Amundsen in 1912. Both the selection process and the race itself were captured in the BBC documentary "On Thin Ice".

Six teams took part from around the world, skiing over 470 miles across Antarctica. The trio, who had little cross-country and no polar experience between them, skied for 16 hours a day in temperatures as low as minus 50 degrees Celsius. They eventually finished in second place, an achievement due in no small part to Ed's clear-headed support and mediation between his two more experienced team mates.

Away from his day job as a consultant obstetrician and gynaecologist in Bath, Ed has represented Britain as a decathlete and swum the English Channel with two different teams. The '30 at 30' project saw him tackle thirty challenges, including the small matter of a Thames swim, a coast to coast race across Scotland and an endurance marathon on Dartmoor.

In presentations, Ed weighs up individual and collective responsibility, and how to form efficient and effective bonds in both new and established groups. He also compares the pressure, determination and teamwork found in the medical world with that required to tackle the toughest environments on Earth.

Affiliated FM Insurance Company.* The plaintiff sought \$30 million, plus interest, for losses caused by Superstorm Sandy and the insurer asserted a coverage limit of \$10 million. After an eight-day trial, the jury issued an advisory verdict affirming the \$10 million policy limit; this verdict was later confirmed by the court.

Liz also represents stakeholders in complex property damage and disaster litigation. Many of these high-stakes matters stem from fires and explosions caused by combustible dust and natural gas. In 2015, Liz and her team obtained summary judgment in an explosion case where the personal injury plaintiffs sought \$65 million in damages. In 2016, she represented a manufacturer following an explosion and fire that killed more than 30 people and injured dozens more at a natural gas refinery. Liz and her team secured a motion to dismiss the plaintiffs' claims with prejudice.


